### President

- Presides at all Executive Board Planning Meetings: Prepares Agenda & maintains order
- Appoints Chairpersons of Committees
- Member of all committees except Nominating Committee
- Is the Representative / Spokesperson for our chapter in all chapter business, or appoints a representative.

### Vice president

- Assists the President
- Temporarily assumes duties of the President if President is absent or disabled. In the event of the death or resignation of the President the VP would ordinarily assume the Presidency.
- Performs other duties to assist the smooth functioning of the chapter

### Historian

- Records the events of the chapter
- Keeps a scrapbook or journal of names / photos of:
  1. Original chapter members
  2. Officers and committee chairpersons and dates of office
  3. Date charter was received and other significant dates
  4. Outreach events and special projects
  5. Special and social events
  6. Biographical sketches
- Make available for inspection all of the above

### Registrar

- Keeps a file of all documents, correspondence and publicity
- Keeps all forms updated for all other organizations that may contribute to our chapter
- Keeps all state, county and city documents current
- Reports to Executive Board the status of our chapter
- Assists in the annual chapter update report to HLA
